### Strategic Giving

Every dollar donated to the TCI-PAC is deliberately given to those legislators who consistently prove they have a vested interest in supporting and improving our industry.

### Grassroots

The TCI-PAC assists companies to get their employees actively involved in the political process through proper training. With TCI-PAC's help, companies have been successful in integrating programs into their corporate culture, including voter registration and training employees on how to interact with legislators on key issues. The TCI-PAC hosts workshops featuring political strategists who share their perspectives on relevant public policy, as well as publishing information relevant to the membership.

## PRESERVING HIGHWAY FUNDS

Act 89 provided an unprecedented level of investment into our state's transportation network. Protecting these funds and ensuring they are fulfilling the promises made to the general public is paramount to the success of Act 89. The TCI PAC is continually working on legislation to keep the highway funds from being siphoned off for other, non-highway purposes. One of the major drains on the state highway fund is a continual and increasing transfer to the Pennsylvania State Police for its general operations providing now over \$800 million annually to their operating budget. If this continues to increase it will harm the state's ability to meet the growing demands of infrastructure maintenance and reconstruction. If the trend continues, the gains made by Act 89 will be completely eroded over the next decade. TCI PAC is working to STOP this increase and begin to reign in this annual funding transfer to more acceptable and sustainable levels.

## PROTECTING HIGHWAY WORKERS

With the implementation of Act 89 the number of highway construction zones is going up. This requires an increased level of attentiveness by not only the worker but the traveling public as well. The TCI PAC is working closely with the leadership in the PA Senate to advance Senate Bill 172 which will permit the use of speed monitoring cameras in major work zones across the Commonwealth. These cameras will allow for automated speed enforcement within work zones and afford a greater level of protection to not only highway workers, but the motoring public as they move through construction zones.

## SEASONAL WORKERS

When the state amended the Unemployment Compensation Act several years ago, an unintended consequence of this action resulted in workers within the industry no longer able to collect unemployment compensation while on seasonal layoff. The TCI PAC successfully worked with legislators in 2016 to amend the law by rolling back the amount of earnings a worker has to earn outside of his or her high quarter in order to qualify for benefit payments. While this "fix" is now law, monitoring its effectiveness going forward will be a top priority of the TCI-PAC.

## ALTERNATIVE FUELS FAIRNESS

Funding for Pennsylvania's entire highway construction budget is derived from highway user fees (i.e. fuel taxes and related driver/motor vehicle fees). With the increasing usage of alternative fueled and powered vehicles (i.e. hybrids, electric cars, natural gas vehicles, etc.), House Bill 1057 was developed to ensure that all highway users are paying their fair share for using the transportation network. The TCI PAC is working diligently to see this legislation enacted so that the fair and responsible money to fund our highway network is paid by the owners and operators of alternative fueled and powered vehicles.
